Who We Are

It is our policy to respect your privacy regarding all information that we may collect from you while operating our website <https://www.cathousefunart.com>.

This privacy policy applies only to the actions of Cat House Fun Art and <https://cathousefunart.com> and users of this website. It does not extend to any websites that can be accessed from this website, including, but not limited to, any links we may provide to social media websites. This policy does not apply to any information collected offline or via channels other than this website.

How We Collect Data From You

<https://cathousefunart.com> can be visited anonymously by the user.

We collect data when:

- you contact us through our website, by telephone, post, email or through any other means;
- you register with us;
- when you chose to receive Cat House Fun Art marketing promotions and news relating to our artistic activities as outlined on the website;
- you use our services;

in each case in accordance with this privacy policy.

Data That Is Collected Automatically

To the extent that you access the website, we will collect your data automatically, for example:

- We automatically collect some information about your visit to www.cathousefunart.com. This information helps us to make improvements to our website content and navigation and includes your IP address, the date, times and frequency with which you access the website and the way in which you use and interact with its content. It includes web browser type and version and operational system.

What Personal Data We Collect From You

We store your information on secure servers.

We will retain your information for as long as it is necessary to provide you with the services that you have requested from us or for as long as the law otherwise permits.
